The conference will present the achievements of Euromed Heritage and engage participants in a debate that will focus on **assessing achievements and how best to build on them for the future of Mediterranean cultural heritage**. It is organized with the support of the Ministry of Culture of Morocco and in collaboration with Ader-Fez. The main output of the conference is a **vision paper** that should inform a new strategy for the future of cultural heritage for the Euro-Mediterranean region.

Day I will focus on a critical assessment of achievements and Day II on perspectives for the future; conclusions and recommendations will be presented on Day III. The morning sessions will essentially present critical themes relative to cultural heritage development and the afternoons will be devoted to discussions around these themes. The participatory approach proposed for the afternoon discussions is based on trust and self-determination among the participants and warrants a high level of true meaningful participation. It puts participants at the heart of decision-making for the future.

Participants include representatives of the authorities in Mediterranean partner countries of the EU, projects partners and representatives of civil society organizations, and international organizations involved in cultural heritage development.
